Mifflin County Library Board of Directors Meeting Minutes

Tuesday, December 19, 2023, at 5:15 p.m.

Meeting was called to order at 5:15 p.m., by MCL Board President, Chris Wagner.

Board Dinner

Susan thanked the board for their support throughout the past year. She also thanked Zane Jerzerick and Catie Breneman for their service on the MCL Board and informed them that they would each have a book added to the library collection in their honor.

Approval of Minutes

Financials

Expenses for November 2023 were \$45,147 and income \$19,503. Susan reviewed the financial pages with the board and explained to the new members the listing of accounts on the "November at a Glance" page. She reviewed that the Kish UNCD and MCSB CD are rainy-day funds with a policy stating that. While the board has earmarked the Kish CDs and FNB CD for expenses associated with upcoming renovations. Susan pointed out that we have received the first stipend from our fingerprinting endeavor for the work done in October. The line item for Rothrock was discussed and board was informed that it would not be present next year because Rothrock is able to order their own books from Ingram. It was noted that we will have
